Jayalalithaa Fisheries University, Nagapattinam-611 002 represented by its Registrar (hereinafter referred to as TNJFU) as the First Part and the Society/Trust of R.C. Diocese of Kottar, Nagercoil, represented by its Chairman of Managing Society/Trustee (hereinafter referred to as the Society/Trust) as the Second Part.

41. The Society/Trust agrees that, Annexure-IV of the approved guidelines for Establishing Fisheries College in the name of St.Devasahayam Institute of Fisheries Science and Technology prescribes the Essential Requirements as guided by AICTE norms and the requirement V therein prescribes that "Information on Website – Every College should have a web site with the following essential information":-

- a. List of Teachers with qualifications and specialization.
- b. CV of all Teachers,
- c. College Governing Council / Management / Advisory Committee,
- d. Display Affiliation Number / GO / MoU"

42. The Society/Trust agrees to follow the Following ONLINE Admission Procedure by the Self Financing College affiliated to TNJFU:-

1. The details of TNJFU admission process is posted in the TNJFU website: www.tnjfu.ac.in which will be updated from time to time as deemed necessary. The terms and conditions including the minimum educational qualification for admission as prescribed in TNJFU website has to be scrupulously followed without any deviation. If any deviation found, it is liable for disaffiliation of Self Financing Colleges affiliated to TNJFU.
2. The candidates who are not applying through TNJFU online admission should not be entertained under management quota by the Self Financing Colleges affiliated to TNJFU. If admitted it will be considered as violation of MoU and attracts disaffiliation from TNJFU.
3. All the admission process (both for Single Window System and Management Quota) are through ONLINE only. No paper documents (application form) would be sent to candidates.
4. The Candidates seeking admissions for both Single Window System and Management quota of constituent and affiliated colleges of TNJFU should apply through online only.
5. Every year the schedule of activities pertaining to UG admission is published in electronic media as well as in the TNJFU website. A series of "On-line Counseling" is being followed during admission until all seats of affiliated college is filled up. If any vacancy arises in UG admission under
